By entering this Promotion, entrants accept and agree to be bound by these Official Rules. Any violation of these rules may, at SRIXON’s (“Sponsor’s discretion, result in disqualification. All decisions of the judges regarding this Promotion are final and binding in all respects.

- PROMOTION PERIOD.** Promotion begins 12:01 AM ET December 7, 2016 and ends 11:59 PM ET July 31, 2017, during which period all entries must be received (“Promotion Period”).
- ELIGIBILITY.** This Promotion is only open to legal residents of the 50 United States and District of Columbia who are at least 18 years old as of the date of entry, except officers, directors, members, and employees of the Sponsor, the judging organization (if applicable), or any other party associated with the development or administration of this Promotion, and the immediate family (i.e., parents, children, siblings, spouse), and persons residing in the same household, as such individuals. - HOW TO ENTER.** During the Promotion Period, try one of the new Srixon Z Series golf clubs by either visiting an authorized Srixon golf club dealer or any golf venue or event where an employee of Srixon is present. After trying the club for at least one shot, obtain a Fitting Sheet from an account representative or the Srixon employee with a unique CODE found at the bottom right-hand corner of the page of the Fitting Sheet. After receiving the sheet and code, visit <http://sweeps.srixon.com> and fill out the required fields for entry, including acknowledgement of understanding the rules outlined in this document. Limit: One entry per person and one entry per e-mail address during the Promotion Period. All entrant information, including e-mail addresses, is subject to the respective [Privacy Policy](#) of the applicable Sponsor.
- WINNER SELECTION AND NOTIFICATION.** Since there are three separate grand prizes, winner selection for each prize will be conducted by random drawing from all eligible entries on or about three different dates:

Each of these grand prizes includes the following: two (2) coach airfare tickets from the major commercial airport nearest winner's primary residence to MKE Airport in Milwaukee, Wisconsin (arriving on Friday, June 16, 2017, and departing on Monday, June 19, 2017); two (2) two-day Gallery grounds passes to the 2017 U.S. Open at Erin Hills for Saturday, June 17, and Sunday, June 18; one (1) standard double-occupancy hotel room for three (3) nights at The Ramada Milwaukee Downtown Hotel (or similar) with check-in on Friday, June 16, 2017 and check-out Monday, June 19, 2017; daily breakfast at the hotel; and, a 3-day midsize rental car with pick-up/return at MKE Airport. The total approximate retail value of this grand prize is \$3,750, depending on itinerary. The other grand prize is a trip for two to the 2017 Presidents Cup, this prize will be given away once. It includes the following: two (2) coach airfare tickets from the major commercial airport nearest winner's primary residence to the New York, New York area (arriving on Thursday, September 28, 2017, and departing on Monday, October 2, 2017); two (2) Captain’s Club tickets to the 2017 Presidents Cup at Liberty National for Friday, September 29, Saturday, September 30, and Sunday, October 1; one (1) standard double-occupancy hotel room for four (4) nights at The Kimpton Muse Hotel (or similar) in New York with check-in on Thursday, September 28, 2017 and check-out Monday, October 2, 2017; and availability for roundtrip hotel/tournament shuttle transfers. The total approximate retail value of this grand prize is \$6,000, depending on itinerary. Actual value of both grand prize packages may change based on various factors, including fluctuations in price for airfare and/or accommodations, and distance between the point of departure and the destination. Ground transportation, meals, in-room or other personal charges at lodging (e.g., mini-bar, movies), telephone calls, gratuities, incidentals, and all other expenses are not included.
